2021 Automobility LA will operate under the following COVID-19 protocols mandated by the Los Angeles County of Public Health and the City of Los Angeles.

Inside the LA Convention Center:

- Everyone over the age of 2 must wear a mask
- Everyone 12 years of age and older must also present proof of full vaccination (more than 14 days prior) or proof of negative PCR or antigen COVID test (within the previous 72 hours). *Please proceed to the Health Credential Verification tent outside the South and West entrances of the convention center to provide proof and receive a wristband for entrance into the building.*

Inside the LA Convention Center:

Automobility LA and the 2021 Los Angeles Auto Show will operate under the following COVID-19 protocols mandated by the Los Angeles County of Public Health and the City of Los Angeles.

Proof of full vaccination:

Participants 12 years of age and over will be required to show proof they have received, more than two weeks prior to entrance into the Los Angeles Convention Center, one of the following vaccines:

United States Citizens:

- Pfizer-BioNTech – 2 doses
- Moderna – 2 doses
- Johnson & Johnson (Janssen) – 1 dose

Non-United States Citizens:

- Pfizer-BioNTech (e.g., COMIRNATY, Tozinameran) – 2 doses
- Moderna – 2 doses
- Johnson & Johnson (Janssen) – 1 dose
- AstraZeneca-Oxford (e.g., Covishield, Vaxzevria) – 2 doses
- Sinopharm – 2 doses
- Sinovac – 2 doses

The following are acceptable forms of proof of full vaccination:

- CDC COVID-19 vaccination card (white card)
- World Health Organization (WHO) vaccine record card (yellow card)
- California Department of Public Health (CDPH) COVID-19 digital vaccination record
- Other COVID-19 digital vaccination record issued by an approved company
- Documentation of vaccination from the healthcare provider or entity that provided the COVID-19 vaccines.
- California Immunization Registry (CAIR2) vaccination record

Vaccination proof should include the person's name, type of COVID-19 vaccine, and the date of the doses administered. The person can show the vaccination card, a photo of the card as a separate document, or a photo of the card stored on a phone or electronic device.

Proof of negative test - Acceptable proof of a negative PCR or antigen COVID-19 test includes a photo identification with testing results that must include the person's name, type of COVID-19 viral test performed, and negative test result. The date when the COVID-19 test was taken must be within the 72 hours prior to entry into the Los Angeles Convention Center. The test results can be a printed copy or on a phone, including an email or text message results from the test provider or laboratory. A COVID-19 self-administered test, sometimes referred to as "home test," is not acceptable.

AND

Face masks are required for everyone over 2 years of age - Guests over the age of 2 are required to wear a face covering that covers both the nose and mouth at all times, unless actively eating or drinking. Gaiters, bandanas, and coverings with exhalation vents are prohibited; a face shield still requires a face covering. For the safety of everyone, guests unable to wear proper face coverings will not be admitted into the venue.

On-Site COVID-19 Testing - Automobility LA and the Los Angeles Auto Show have partnered with Medea Testing Solutions (Medea) to provide COVID-19 rapid antigen testing. Guests should bring a copy of their insurance card/info and government-issued ID if available, though guests can be tested regardless of documentation and whether they have insurance. Guests must wear a face mask in the testing area.

Medea's testing site will be located outside the front entrance of the Los Angeles Convention Center. Results are provided to the guest electronically within 10 to 15 minutes. Only results for testing completed within 72 hours will be accepted for entry into the Los Angeles Convention Center. Guests are strongly encouraged to preregister in advance of their arrival to the Los Angeles Convention Center through Medea's website: <https://medeatesting.com>. Testing will be available each day of the event including move-in and move-out.

Refund Policy – Purchases made directly through Automobility LA, or the LA Auto Show are final and non-refundable. If either event is cancelled due to COVID-19, you will be issued a refund within 60 days of that cancellation. If you have paid a registration fee or ticket fee, have tested positive for COVID, and are following isolation/quarantine guidelines during the 2021 LA Auto Show, you may also be eligible for a refund. Please provide a copy of your positive test result to help@laautoshow.com. All requests must be received before the closing date of each event. If you purchased your tickets through a 3rd party program, you must contact them to request a refund.
